### Introduction:

Protecting your privacy is very important to us. **Information We Collect:**

Touring Health may collect certain information when you access or use our Site. This information may include location information, IP address, device identifier, browser type, domain name, operating system, information about your use of our Site, internet service provider, pages that you visit before and after using our Site, the date and time of your visit, information about the links you click and pages you view within our Site, and other standard server log information. We may use various tools such as cookies, web beacons, and other online tracking technologies to collect this information. We may combine certain automatically collected information with additional information we obtain about you, which may include information we obtain from third parties.

We collect your information from the following sources:

- Information you give us, such as during registration on our Site (which may include your name, date of birth, user name, password, and email address), Site interactions (like rating services/products, joining a forum, customer service operations, purchasing, scheduling, support requests, surveys, leaving a review, download of a software update), and any other Site transactions;
- Information from other sources, such as a site platform provider or a company that helps us to track our application use or update our records; and
- Information automatically collected when you visit or use our Site or interact with us, such as tracking technologies, via cookies, usage information, and device information (this could include your location information or IP address, activity information, technical, usage, or device data).

NOTE: Touring Health may also collect your name, contact information, phone number, date of birth, state, country, zip code, email address, health information, or login identification information only if you provide such information directly to us when you begin registration to use our Site on our Secure Platform or complete a form requesting such information for us to provide services to you through our Site.

Personal information is information that identifies you or is reasonably linked to you. In addition, we may collect information from consumer reporting agencies or other service providers if you obtain certain financial products.

## **Automated Information Collection**

We receive and store certain types of information when you interact with our Site, emails, and online advertising. Our purpose is to allow our Site to work correctly, to evaluate the use of our Site, and to support our Site's analytics and marketing campaigns. Some examples include:

- We may collect technical information such as your internet protocol address, device operating system, browser type, the address of a referring website, if any, and the path you take through our Site.

- Touring Health may use the information collected to prevent and address fraud, breach of policies or terms, and threats of harm.
- Touring Health may use the information collected to personalize your interaction with the Site, conduct surveys or promotions, respond to any comments, questions, emails, or requests from you, or provide you with information that we believe may be useful to you, such as latest product/service announcements, important notices, software updates, and upcoming events. Touring Health may use personal information to help us develop, deliver and improve our products, services, content, and advertising.
- Touring Health may also use personal information for internal purposes such as auditing, data analysis, and research to improve Touring Health's products, services, and customer communications.

If you enter a sweepstake, contest, or similar promotion, we may use the information you provide to administer those programs.

## **Disclosure to Third Parties**

At times, Touring Health may make certain personal information available to our strategic partners or affiliates that work with Touring Health to provide products and services or that help Touring Health market to customers. Touring Health will only share personal information to provide or improve our products, services, and advertising; it will not be shared with third parties for their marketing purposes or any other use. We may share your Personal Information connection with an asset sale, merger, bankruptcy, or other business transaction.

The third parties with whom Touring Health may share personal information include companies who provide services such as information processing, fulfilling customer orders, delivering products to you, managing and enhancing customer data, providing customer service, assessing your interest in our products and services, and conducting customer research or satisfaction surveys. Touring Health may provide your personal information in response to a court order, subpoena, search warrant, or other legally valid inquiry or order, or to an investigative body in the case of a breach of an agreement or contravention of law, or as otherwise required by applicable law. Touring Health may cooperate with law enforcement authorities in investigating and prosecuting illegal activities, violate our Terms of Use, or may be harmful to others.

## **Cookies and Other Technologies**

Touring Health's website, online services, interactive applications, email messages, and advertisements may use various technologies, now and hereafter devised, that automatically collect certain usage information whenever you visit or interact with our Site. Usage information may be collected by various methods, including, but not limited to, "cookies" and other technologies such as pixel tags, web beacons, mobile device identifiers, and embedded scripts.

- Cookies are small data files that a web browser places on your computer when it is used to visit a website. The use of cookies is a common practice on many websites. We may place cookies on your computer to allow us to recognize you on our website during future visits, to measure web traffic, to offer you certain products or services, or to customize your visit. Your Internet browser may include settings that permit you to block cookies or to be notified when cookies are placed.
  - Some cookies we use are "session" cookies, meaning they are automatically deleted from your device after you close your browser at the end of your session. Session cookies are used to optimize the websites' performance and limit the amount of redundant data downloaded during a single session. We also may use "persistent" cookies, which remain on your computer or device unless deleted by you (or by your browser settings).
  - We may use persistent cookies for various purposes, such as statistical performance analysis, to ensure the ongoing quality of our services.
  - We and third parties may use session and persistent cookies for analytics and advertising purposes, as described herein. Most web browsers automatically accept cookies, but you may set your browser to block certain cookies (see below). In accordance with applicable law, we may obtain your consent separately before collecting information by automated means using cookies or similar devices.
- Our Site may use Google Analytics, a vendor's service that uses cookies, web beacons, web pixels, and/or similar technology to collect and store anonymous information about you.
